Summary

Reporting to the Director, Environmental and Regulatory Affairs, the Environmental Manager is responsible for leading all activities related to environmental programs, regulatory applications, and compliance.

Responsibilities

- Coordinating and managing compliance of health and safety requirements for environmental field programs
- Critically assessing environmental conditions in the field to evaluate potential environmental impacts from exploration activities
- Supporting compliance audits against permit/licence requirements and social obligations
- Supporting the implementation of environmental monitoring, sampling, and inspection schedules
- Preparing daily and weekly inspection reports and/or reviewing inspection reports from other field staff
- Preparing environmental and health and safety training materials and conducting training for field staff
- Maintaining and auditing environmental equipment as required
- Reviewing technical reports generated by environmental consultants to ensure alignment with corporate goals
- Being responsible for the preparation of permit applications and track approvals, or amendments as required
- Supporting environmental budgeting, cost management, and site and corporate reporting activities
- Administering and managing logistics and resources associated with environmental program execution within allocated budgets
- Supporting the implementation of ESG metric tracking

- Responding to, investigating and managing environmental incidents and supporting the development of effective and practical corrective actions
- Managing an internal team of Environmental Coordinators, and/or contract staff
- Supporting the Environmental & Community team as required
- Supporting the management of the environmental assessment team including external specialists and scientists responsible for conducting environmental, social, economic, heritage, and health assessments based on the environmental assessment
- Supporting the development and review of environmental assessment documents in collaboration with an internal Project Team and external technical experts
- Managing Environmental field crews and consultants to ensure completion of field programs
- Managing the implementation of environmental monitoring, sampling, and inspection schedules, as well as managing and directing staff and consultants' schedules and responsibilities
- Owning accountability for water, waste, wildlife, air, and aquatic health monitoring programs (e.g., fisheries, environmental effects monitoring, land disturbance and biodiversity management), spill response, erosion and sediment control, industrial inspections, Safe Work Procedure (SWP)/Standard Operating Procedure (SOP) development, scheduling, data assimilation, interpretation, and drafting reports
- Implementing or supervising the implementation of the Environmental Management System (EMS) and its component Environmental Monitoring Plans and related Standards of Practices, and other environmental requirements, as directed
- Performing other duties associated with this position as may be required

- Bachelor's degree in environmental science, Engineering, or related field.
- Minimum 8 years of progressive work experience, including environmental/regulatory affairs.
- Experience with the mining industry
- Experience working with regulators related to permit compliance.
- Working knowledge of the applicable territorial and federal environmental regulations.
- Familiar with current regulatory, environmental assessment, and permitting practices.
- Northern experience is an asset.
